

Matriculation

1. Enrolment conditions

Persons who have completed the following are eligible for admission to the English-language university degree programme "Digital Agriculture":

- An appropriate undergraduate university degree (in the field of biotechnical sciences) with 180 ECTS credits.
- An undergraduate degree in the field of biotechnical sciences (food technology, forestry, biotechnology and nutrition).
- An undergraduate degree programme with 180 ECTS credits in the fields of natural sciences (biology), technical sciences (computer science) and social sciences (economics), whereby certain differentiation obligations must be fulfilled during the degree programme.

2. Applications for enrolment

Applications for enrolment will be accepted until **28 September 2024** (until 12:00 noon).

Applicants must submit their application documents for the selection procedure either in person or by post to Faculty of Agrobiotechnical Sciences Osijek, Vladimira Preloga 1, 31000 Osijek. Applications sent by post must be received by **28 September 2024**.

The list of candidates who have the right to enrol in the University's graduate programme will be published on **1 July 2024** or **29 September 2024** by 12:00 noon.

Documents for the application

The following documents must be attached to the application:

- A diploma or certificate of completed undergraduate studies, completed professional studies or completed professional specialised studies.
- Transcript of Records or Diploma Supplement.
- Proof of citizenship (a copy that does not need to be notarised; the date of issue of the proof is not limited; the proof can be generated from the e-Citizens database), a Croatian citizen who is not a citizen of the Republic of Croatia must provide proof of Croatian citizenship.
- Birth certificate (a copy that does not need to be notarised; the date of issue of the birth certificate is not limited; the birth certificate can be generated from the e-Citizens database).
- Foreign nationals must provide proof of citizenship of their country.
- Proof of payment of enrolment fees.

Selection procedure for the university programme Digital Agriculture (Digitalna poljoprivreda)

The selection procedure is based on:

- a) the assessment of the success of the basic studies (average study grade) and
- b) the specialisation of the completed undergraduate studies.

The candidate's overall score is the product of the weighted average of all grades achieved during the undergraduate programme and the factor (depending on the subject area of the completed degree), as follows:

- a. Biotechnical sciences: weighted average $\times 1$
- b. Natural sciences (biology): weighted average $\times 0.95$
- c. Technical sciences (computer science): weighted average $\times 0.95$
- d. Social sciences (economics): weighted average $\times 0.90$

Candidates are ranked on the basis of the total score.

The matriculation of candidates will take place on **3 and 4 July 2024** or on **30 September and 1 October 2024** at the Office for Students and Studies.

Original documents and a registration form received at the time of enrolment must be submitted for enrolment. Proof of payment of enrolment fees and proof of payment of tuition fees must also be submitted.

A candidate who does not use the right of enrolment within the period in which the right was acquired loses the right of enrolment.
